## 1. New Parental Support Program Kicks Off October 1/CLE Set for October 15

Starting October 1st the Law Society of Manitoba will be offering a free and confidential parental support program. The program will provide lawyers with coaching sessions designed to help them plan for maternity and parental leave and meet the challenges of becoming new parents. Six coaching sessions will be provided by Brenlee Carrington Trepel, the law society's <u>Equity</u> <u>Ombudsperson</u>, with additional resources offered through Blue Cross Manitoba. The sessions, which will include the lawyer and his or her spouse or life partner, will focus on issues such as how to discuss leave and transition options with the lawyer's firm, handling the new dynamics of having a family, and successful reintegration into practice while juggling career and home life.

The Law Society program is modelled on one introduced at the McCarthy Tetrault firm in Ontario by the firm's regional managing partner, <u>Kirby Chown</u>.
