EI Special Benefits for the Self-employed

[Bill C-56](#), *Fairness for the Self-Employed Act*, introduced November 3, 2009, proposes to extend employment insurance special benefits (including maternity and parental leave) to the self-employed, provided they opt into the program at least one year before making a claim. Those who opt in would not have to pay the employer portion of the premium, since they would be limited to special benefits only. The legislative summary explains the intent of the bill and the *Lawyers Weekly* article [Self-employed lawyers may get Employment Insurance](#) canvasses the reaction of the Bar.
