## Lawyers Liable for GST on Disbursements Absent Agency Agreement: FCA

Merchant Law Group was recently found liable for the GST it failed to collect from clients on what it thought were exempt disbursements in [Canada v. Merchant Law Group](#), 2010 FCA 206. Merchant had argued that it was acting as agent for the client when it incurred disbursements for searches, courier costs, transcripts, certificates, etc., and that these expenses were therefore GST exempt. The court disagreed, finding that an exempt disbursement may become taxable if it is an input to a lawyer's services as was the case here. The court proposes a solution to this situation at para. 33: "...a written agreement appointing the lawyer as the client's agent, expressly delineating the scope of a genuine agency relationship between the lawyer and client and directing that certain disbursements be incurred and paid on the client's behalf."

The [research primer](#) and [guide](#) summarize the legal research process and provide tips on how to make the most of the many free online resources.

## Managing Risk

The [Avoid a Claim](#) blog article [Recognizing Risks and Avoiding Malpractice Claims](#) includes the alarming statistic that four out of five Ontario lawyers will face at least one malpractice claim in the course of their careers. Many claims are preventable, however, and most do not arise from failure to know or apply the substantive law. This [table](#) shows the most common legal malpractice claims by type of alleged error for selected claims from both the United States and Canada.

There are many online resources which can be used to reduce the threat of legal malpractice exposure. Two of the better recent publications are the summer edition of *Law Practice Magazine*, titled [Avoiding Malpractice - Are you at Risk?](#), and the article [Reducing Risk Through Effective Practice Management](#), by George Hendy, Patrick Cassidy and David Paul, published by the Canadian Bar Association in follow up to the [2010 Canadian Legal Conference](#).

## Resources for Small Firm and Sole Practitioners

The American Bar Association's [Smart Soloing Center](#) is a new online resource for sole and small firm practitioners. It gathers content from [law magazines](#), [blogs](#), [discussion lists](#) and [news feeds](#), and provides [links](#) to technology, research and practice management resources. Although American based, much of the content applies generally.

## Project Management

## More on Metadata Mining

Following up on the item on Metadata Ethics in June's eLaw, here are some practical suggestions for ensuring your documents are not putting you at risk. [The ins and outs of metadata mining](#) by Luigi Benetton, published September 24, 2010 in *Lawyers Weekly*, lists eight techniques for checking a document for metadata. Making a PDF of a document before sending it out as some firms recommend won't necessarily eliminate metadata, as noted in the article [Scrubbing Metadata from PDF Files](#), which recommends that even PDF documents be scrubbed. The articles [Protect Your Documents From Prying Eyes With Privacy Settings](#) and [Adobe's Advice on Purging PDF Documents of Metadata](#) discuss the features in Word and Adobe Acrobat that help control transfer of metadata.
