Failure to Notify Insurer Can Be Professional Misconduct: MBCA

A lawyer may be found guilty of professional misconduct for failing to give notice of a potential professional liability claim to the Law Society's Director of Insurance according to the Court of Appeal in [Luk v. Law Society of Manitoba](#), 2011 MBCA 78. The court rejected the appellant's argument that a finding of professional misconduct necessarily requires a finding that the impugned conduct was dishonourable or disgraceful. The appellant also argued she had a reasonable excuse for not notifying the insurer, since the amount of the potential claim was less than her deductible and she felt she would be able to correct the mistake. The court concluded:

Section 65 of *The Legal Profession Act*, C.C.S.M., c. L107, authorizes the benchers of the Law Society to make rules, *inter alia*, to prescribe which contraventions of the governing statute or the rules may constitute professional misconduct. The benchers have done that in Rule 5-36, and we agree with the Law Society that lawyers may be found guilty of professional misconduct for failure to notify the Law Society as required under Rule 5-34, even if such violation has no element of dishonourable or disgraceful conduct. B.C. Court Exempts Lawyers From Money Laundering Rules

The B.C. Supreme Court struck down sections of the *Proceeds of Crime (Money Laundering) and Terrorist Financing Act* and regulations requiring lawyers and law firms to maintain records on the identity of their clients when acting as financial intermediaries in [Federation of Law Societies of Canada v. Canada \(Attorney General\)](#), 2011 BCSC 1270. The action was a test case brought by the Federation of Law Societies, with the Canadian Bar Association as intervener, and the result applies to lawyers across Canada. The CBA summarised the import of the decision as follows:

The decision underscores the importance of solicitor-client privilege and confidence in our system of justice. It also serves to strengthen the role of self-regulation, recognizing that law societies are best situated to regulate the conduct of lawyers because they can do so in the public interest, while at the same time maintaining protections for solicitor-client privilege.
